Application Fees

Parent Toddler Program

- **CMS Membership \$120 per year** (inclusive of GST) invoiced annually.
Please note, families must be financial members for each calendar year that their child is on a waitlist and while attending the school.

- **CMS Membership \$120 per year** (inclusive of GST).
Please note, families must be financial members for each calendar year that their child is on a waitlist and while attending the school.
- **Application Fee \$120** (inclusive of GST).

Enrolment Fees: Cycle 1 – 3 only

After your child is offered a place in Cycle 1 – Cycle 3, the following enrolment fee applies:

- **Capital Entry Fee:** \$1400 once per family, non-refundable

- Tuition fees are invoiced in advance each term.
- All fees should be paid via a Direct Debit Request – forms available at office.
- We recommend a payment plan for parents who would like to pay monthly or fortnightly.
- Minimum attendance for children in their pre-Kindergarten years is 8.45am – 12pm Monday to Friday.

Other Fees

Early Extended Day (Optional)

Cycle 1 – pre-Kindergarten years, 12pm – 3pm Monday to Friday – <i>CCS applies – full time only</i>	\$1,650	\$6,435

- Families who opt for their pre-Kindergarten child to stay for the full school week from 8.45am – 3pm (Early Extended Day) are charged additional fees for the afternoons because these children are not covered by government funding.
- These additional fees are invoiced fortnightly in arrears separately to the morning tuition and are eligible for the Childcare Subsidy.
- The per term amount is an indicative averaged amount. The actual EED fees change each term as it is not charged for public holidays or Pupil Free Days.

Voluntary Building Fund Donation (tax deductible): \$115 per family per term

Voluntary Bursary Fund Donation: \$50 per child per term

All of the above Out of Hours School Care fees are eligible for the Child Care Subsidy and are invoiced in arrears each fortnight.

Discounts

- Sibling discount for second child: 15% off the second child's tuition fee
- Sibling discount for third and subsequent children: 20% off the third and subsequent children's tuition fee
- Advance payment discount: 5% on payment of 2019 full year's tuition fee (after sibling and staff discounts are applied) by 30^{1st} January 2019.
