| 4.1 | CMS Membership | \$120 | Families must be financial members for each calendar year that their child attends the school. Families joining from Term 3 in any year, will be charged \$60 for the remainder of the year. |
| 4.2 | Capital Entry Fee | \$1600 | Payable on acceptance of a place in Cycle 1, 2 or 3, for the first child in a family. This is a per family fee. Nonrefundable. |

| 4.1 | Cycle 2 and 3 | \$12,245 | \$3,061.25 /term |

| 6 | Discounts on Tuition Fees | | |
| 6.1 | 2 nd Child Sibling Discount | 15% | Off 2 nd child's tuition fees |
| 6.2 | 3 rd & Subsequent Siblings Discount | 20% | Off the 3 rd and subsequent child's tuition fees |
| 6.3 | Year in Advance Discount | 5% | Annual tuition fee payments attract a discount. To receive this discount, fees must be paid by 31 January, via direct debit or direct deposit. |
| 6.4 | Staff Discounts | 25% | On School Tuition Fees only (after sibling discounts have been applied) |
| 7 | Voluntary Tax-Deductible Donations | | |
| 7.1 | Building Fund | \$460 per year per family | Donations to the Building Fund are tax deductible and are used to improve the facilities. |
| 7.2 | Bursary Fund | \$200 per year per student | Bursary Fund donations are used to help families with financial hardship. |

| 11.1 | CMS invoices are produced from two different software programs, depending on whether there is a CCS rebate applicable. This means that you may receive two separate invoices and have 2 different direct debits in place. | | |
| 11.2 | CCS applicable programs will be invoiced in two-week blocks. | | |
| 11.3 | <p>CCS (Childcare Subsidy): For eligible families, CCS will be paid directly to CMS and will reduce daily charges. To access CCS, you must:</p> <ol style="list-style-type: none"> 1. Sign into your myGov account. If you do not have one, you will need to create a myGov account. 2. Link myGov to Centrelink. You can do this under Services in myGov. 3. Select Centrelink and complete the Childcare Subsidy Assessment. <p>Once you have received your CCS assessment letter from Centrelink, you will need to provide the School with your and your child’s CRN details, to enable the School to apply CCS payment from Centrelink to your fee account. It is important that the School receives both CRNs to achieve this connection with Centrelink.</p> <p>Once a connection with Centrelink is made, you will receive notification to approve the enrolment with CMS. Instructions on how to do this can be found at Services Australia.</p> | | |
